UPDATES FROM MS OSBORNE

Attendance

Attending school every day can help your child to achieve their aspirations, and the aspirations you have for them. School attendance is also important for giving them the enrichment opportunities that can help support their social and mental wellbeing.

The research on the link between attendance and attainment is clear; the students with the highest attendance throughout their time in school gain the best GCSE and A Level results.

We appreciate that it can be difficult to know whether your child is too ill to attend school. However, NHS guidance is clear that it is fine to send them in with a minor cough or common cold, provided they don't have a temperature.

We aim for all our students to have an attendance rate of 95% of above. You can monitor your child's attendance data through the Schoolgateway app and ensure that it remains at this rate. If there is anything that we may be concerned about, your child's form tutor, Head of Year, or I will contact you.

New guidance on attendance

In February, the Government published new guidance for attendance which became statutory in August. These changes reflect amendments to the law and are part of the Government's drive to improve attendance at school. Deails are <u>here</u>, along with links to wider guidance on supporting your child's attendance. The full guidance is <u>here</u>.

A reminder that the Government has an <u>attendance hub</u> which can help parents make informed decisions about attendance. The Government also provides parents with guidance around illness and attendance at school. This <u>guidance</u> helps parents make informed decisions about their child's health and attendance.

Cambridge Biology Challenge

October 2024 saw the launch of this year's Cambridge Biology Challenge. Run by Homerton College, this nationwide competition challenges students to think deeply about the sort of questions that they ask at Cambridge. The first question was 'Does behaviour fossilise?'

Homerton College received over 700 entries, nearly double that of last year! Over 50 Nonsuch students from Y10-12 entered and we had some brilliant results, in particular many commended and highly commended certificates. Well done to all who entered!

Physics Enrichment Club Years 11-13

Physics Enrichment club for Years 11-13 has been running fortnightly for the first term. Our main aim is to prepare for supra-curricular competitions, specifically the suite of exams run by the BPhO.



Certificates are on the way to the students who participated in each of these competitions in the first term, as well as prizes for the high achievers. We are incredibly proud of all of them.

British Physics Olympiad Challenge (A2 Open Competition)

This exam contains questions that relate to A level (or equivalent) topics, but it is much harder! It is to stretch thinking into the applications and ideas of Physics and may be inspirational for university and further work in Physics. Keira, Nethra, Nethira, Rithika, Carrie, Michela, Ibtida, Ashritha, Veronika, Juhi and Yea-Eun all achieved certificates of participation. Yilin, Aree and Vishmayaa all achieved Merits and will also get book prizes.

British Astrophysics and Astronomy Olympiad Challenge (A2 Open Competition)

Kajeeva and Yilin are both passionate about Astrophysics, so took on the challenge of a self-study course in Astrophysics and Astronomy and took part in the BAAO Challenge exam. Kajeeva achieved a very impressive Merit and Yilin was awarded a Distinction certificate!

British Physics Olympiad (A2 Selective Competition)

Some highly impressive students were selected to enter the British Physics Olympiad, which means that they volunteered to sit an exam paper in their own time! The paper was designed to stretch and challenge the top young physicists in the country in a national competition, so every question is a real challenge for even the most capable. Vishmayaa achieved a Bronze certificate, Aree achieved Silver, and Yilin scored Gold. Well done!

DT - Accelerate Studios Architecture Workshop

On Thursday 10th January, Year 10 Product Design students took part in an Accelerate Studios architecture workshop and learnt about careers in the built environment. Research into designers inspired students designing a new façade for Nonsuch High School. They sketched ideas independently and then discussed their ideas working collaboratively, putting the best ideas together.

Modelling was the next step, where students encouraged to use different methods to enhance their designs like folding paper to create texture,



nets, use of colour to highlight parts of the model as well as including landscapes and animating by adding people to show how the building would be used.

The session finished with students presenting their ideas to Accelerate Studios and the rest of the class.

The new façades for the front of the school took advantage of using space on the external walls for services and stairs, giving more space, particularly in the corridors inside the building. A couple of the designs included oversized initials and a logo of the school. This was a fun practical activity which was a great opportunity to find out more about careers in architecture. Rights Respecting School Steering Group

An article by the Rights Respecting Schools Steering Group on Article 9 of the UNCRC, Right to Family Reunification

The UNCRC states that children have the right not to be separated from their parents, unless it is in their best interest. Despite the importance of family life for children, relatives have often been forced apart due to unforeseeable circumstances.

In January 1961, Sigrid Paul arrived at a hospital in Berlin's eastern zone, going through labour. During the birth,



her baby - Torsten - was seriously injured. Nobody knew if he'd live or die. At that time, Sigrid and her husband, Hartmut, could cross to the West. Reaching a better-equipped hospital, Torsten's life was saved and although still fragile, he was allowed home. As long as Sigrid could pick up his medicine and special food from the West, he would survive.

But on August 13th, 1961, she no longer could. The night before, East Germany had constructed the Berlin Wall, dividing the city for nearly three decades. When Sigrid woke the next morning, she couldn't travel to the West. Torsten's condition worsened.

Back in hospital, he became sicker, needing western care. Transferring patients west was forbidden, except in heart cases, so seeing no other option, his doctors falsified Torsten's papers to save him.

Although able to recover, he was now alone in West Berlin. Sigrid was eventually granted a visa to visit him for a few hours, but crackdowns on visits were only increasing. Two weeks after sheltering three students, the couple were arrested, imprisoned and charged with failing to reveal their plans to escape. Meanwhile, Torsten remained in the western hospital.

Sigrid and Hartmut, due to an agreement between East and West, were released early. Almost a year later, Torsten returned home. Unfortunately, due to their separation, it took time before he began to truly see her as his mother. Later, though, Torsten began to flourish and grow evercloser to Sigrid. Remembering the moment the wall fell in 1989, Sigrid said that "I was exhilarated."

Despite the great adversity their family faced, and the anger that she still feels, they managed to reunite against all odds.

- Clarification of language around Pupil Premium, changing "in receipt of Pupil Premium" to "eligible for"
- The addition of 'young carer' as a category as part of the prioritisation for Sixth Form places and an additional Supplementary Information Form to submit supporting evidence.
- Clarification of when offers to Sixth Form are made.
- Clarification of the process about mid-term admissions to years 10 and 11.
